This Clarification No.3 is issued in accordance with the ITB 7.1 of Section 1 (Instructions to Bidders) of the Bidding Documents.

1.	Is the construction period of this project determined to be 2 years?	Yes. Please refer to P.C.C. 1.1.84.	
2.	The bridge foundation is designed as a caisson foundation. However, according to the on-site inspection, the original base of the bridge is block stone and the foundation conditions are good. It does not meet the settlement requirements of a caisson foundation. Can the foundation type be modified?	Please follow the existing Drawings and Bill of Quantity (BoQ) that have been issued. If there any changes necessary it would be made on construction period, after the preparation and approval of the Shop Drawing. Additional Note: The changes during construction o variation orders proposed by the contractor should no affect the original cost and must include the submission o design verification for the foundations by the contractor to ensure the integrity and safety of the bridge.	
3.	If there are differences between the BOQ, standard specifications, and drawings, which document should be considered the main reference and hierarchies?	Please read the Contract Agreement for Order of Priority of documents.	
4.	Please inform us regarding the compensation or terms applicable in case of delayed payment from the Employer.	Please refer to P.C.C 14.8	
5.	Please clarify which parties are authorized to approve the design, materials, progress and payment of the works.	MPW and A.D.N (National Development Agency)	
6.	What types of permits or licenses fall under the responsibility of each Employer and Bidder?	Environmental License fall under the responsibility of the Employer. All other permits or licenses fall under the responsibility of bidder - A mineral license by the Autoridade Nacional dos Minerais (ANM) or Mineral Permit, Under the responsibility of Bidder/Company.

10.	What are the capacity requirements for each heavy equipment unit (Wheel Loader, Motor Grader, Water Tank, Vibratory Roller, Stone Crusher Plant, Conc. Batching plant, Asphalt Sprayer, Air Compressor, Generator Set, Asphalt Distributor)? Can this be based on the calculation of equipment requirements in the unit price analysis?	Yes Using the Unit Price Analysis (Scope of Work, Productivity, Selecting Equipment), ensure alignment with the project's needs.	
11.	The tender document specifies a requirement for an Asphalt Mixing Plant (AMP) with a capacity of 40 m³/hour at least 92 ton/hour with asphalt spesific gravity conversion 2,3 ton/m3. However, our available AMP has a capacity of 80 tons/hour. Based on our calculation, the required asphalt tonnage and project duration can be met with the 80 tons/hour AMP. Would it be acceptable to use an AMP with a capacity of 80 tons/hour instead? If not, can we submit two AMPs to accommodate the required capacity?	If your AMP can meet the required asphalt tonnage and project schedule, you can present this as part of your technical proposal, emphasizing its efficiency and ability to deliver results without compromising the timeline.	
12.	Is it permitted/possible to carry out earthwork or other work using dump trucks at locations with a capacity of more than 10 tons?	Yes	
13.	We would like to clarify whether a support letter from the equipment vendor can be accepted as a supporting document for key equipment availability.	Yes	
14.	For Safety Officer and Environmental Officer, Is it possible if we have a college degree is irrelevant education but has a proof of professional expertise that is appropriate / relevant with position requirement?	The score will be given based on Qualification & Experience.	
15.	Can the excavated stone/soil material be reused for other work materials if it meets the specifications?	Yes, excavated stone material can be reused for other work materials if it meets the required specifications. The Key consideration by Contractor: Obtain certification or approval from the project's quality control (Laboratory) team or supervising engineer and Cost Saving.	
16.	Based on the site visit, there are many utility pipes across the road. If a pipe needs to be replaced during the work, can the contractor file a claim?	No. The contractor will put it in the unit rates. The contractor shall propose the cost in the proposal for the quantities. That cost will be paid for the pipe replacement service by another institution or Be'e-TL.IP.	
17.	Is there a quarry location provided/recommended by the owner? If so, where is it located and how far is it from the project location? Please state the coordinates.	Please see the PROPOSED MATERIAL SOURCES, SITE CAMP & STOCK drawing

18.	In drainage work, can the design using stone masonry be replaced with a u-ditch precast to speed up the work?	Yes. If the future contractor proposes to change the design or drawings of the contract, it is possible through a Variation Order proposal, subject to the conditions mentioned in the FIDIC or contract. The proposed material changes must be of the same quality or better and must not alter the design related to the water discharge capacity calculated by the designer. Additionally, the changes must not affect the cost to the Employer or result in any additional expenses.
19.	In retaining wall work, can a retaining wall with stone masonry be replaced with a concrete retaining wall?	Yes. If the future contractor proposes changes to the design or drawings of the contract, it can be done through a Variation Order proposal, in accordance with FIDIC Clause 13 (Variations and Adjustments) or the relevant provisions of the contract. The proposed material changes must be of the same or higher quality and must not compromise the design's safety factor or the durability of the retaining wall. Furthermore, the changes must not increase the cost to the Employer or result in any additional expenses.
20.	Whose responsibility is land acquisition?	The Employer would be responsible for land acquisition.

Any modifications in drawings will be discussed with MPW and A.D.N during implementation.
