The USB containing the Technical Proposal shall be placed inside the Technical Proposal envelope, and the USB containing the Financial Proposal shall be placed inside the Financial Proposal envelope. 4. The fourth payment equivalent to 50% of the contract price will be paid to the design consultant after the Final report has been reviewed, approved and submitted to the owner.

The employer shall retain 5% from each progress payment as Performance and Quality Guarantee for satisfactory performance of the Contract. The 5% of retention money will be paid to the Consultant until the finalization of the procurement process.
