- A compulsory pre-bid training will be held from **17 to 19 May 2016** starting at 0900 am to 1700 pm hours local time at **Meeting Room of MOPTC-R4D Baucau**. It is mandatory to attend the pre-bid training for 3 days.
- The bids must be received in the Tender Box located at the same address specified in **point 6** above (at **Meeting Room of MOPTC-R4D Baucau**) no later than **10:00am local time on 31 May 2016**. Late bids will not be accepted and will be returned un-opened to the bidder.
