7. The bids must be received in the Tender Box at **National Procurement Commission** no later than **15 : 00pm local time on 18 October 2016**. Late bids will not be accepted and will be returned un-opened to the bidder.

8. Bids must be accompanied by a bid security as specified in bidding documents

9. Technical Bids will be opened immediately after the closing time for the submission of the bids at the same address specified above in the presence of bidders who wish to attend.
