- The bidder failed to meet the requirement of minimum 200m bridge construction for Lot 2 & combined lots. Therefore, the bidder is considered as non-responsive to construction experience in similar key activities for Lot 2 and combined lots but the bidder is meeting the experience in key activities requirement for Lot 1.

- The bidder passed the construction experience in key activities requirement for Lot 1 but not for Lot 2 and combined lots.

- The bidder had successfully completed two contracts within the last five (5) years and that are similar to the proposed works, where the value of the bidder's participation exceeds US\$18.50 Million, therefore, the bidder meets the construction of similar size and nature for Lot 1 only, but not for Lot 2 and combined lots.
- The bidder passed the construction experience in key activities requirement for Lot 1 only.

- The bidder failed to meet the requirement of construction experience in similar key activities for Lot 2 and combined lots but complied with the construction experience in key activities for Lot 1.
