In accordance with Article 89 Decree Law 10/2005 of the Procurement Legal Regime, the National Procurement Commission would like to announce its intent to award the following contracts:

Consistent with Article 86 No. 11 of Decree Law 24/2008 of the Procurement Legal Regime, the Price Bid of the top two bidders in the detailed technical evaluation of bids, Mondego International, Unipessoal Lda for Lot 1 and Sun Timor, Lda for Lot 2, were opened with the following prices and price scores. To determine the "price score", the lowest evaluated bid price "X" will automatically score 500 for the price component evaluation.
